# **ATV/UTV Parking at Fire Department**

On December 18<sup>th</sup> there was an organized ride by David Peardon that brought about 70 machines into the Village of Sullivan, but they parked them all at the Sullivan Fire Department, which has no parking signs around the property.

The GLIDE Snowmobile/ATV Club was present at the meeting. They came to advocate how much work they have put into getting these trails approved and how much the clubs appreciate having the trails in the local municipalities. They brought forth ideas to the board about how to possibly fix the problem with parking.

The board wants to come up with a fix for this issue, and has chosen not to close the trails at this time. The discussion will continue at the next board meeting. GLIDE will come up with more ideas on how the parking issue could be fixed. All Village of Sullivan business owners will be asked to attend the February board meeting as well.

#### **Fire Department**

#### Report

Chief Flood reported that the radios, as discussed earlier, have a lot of static lately when paging is being done.

The department has responded to 95 calls for 2021, which is the most they have had.

Sullivan, Rome, and Helenville officers sat down and had a discussion about Helenville not having enough personnel and to come up with a possible solution with other departments to help them out. This was a beginning discussion and nothing has been decided.

The decision was made because even with the improvements there was no guarantee that it would improve the water problem that is affecting the block on the building.
