#### **Approval of Electrical Work at Park**

A McHugh/Gross motion carried on a voice vote to approve the electrical work up at the park in the amount of \$790.00. The work will include moving an electrical switch, fixing the light above the VFW door and making sure the light is on a switch and not dusk till dawn, and adding a light by the back kitchen door that will also be on a switch.
