Fire Department

Report

Chief Flood reported that they are up to at least 72 calls for the year.

All the trucks have gone through their yearly maintenance and none of the trucks had to have big repairs done.

The Halloween Parade brought in about 80 kids for the costume judging and having everything at the Fire Department worked out very well.

Truck Updates: The brush truck is completed and should be delivered by the end of the week, but we are still waiting on equipment and accessories for the truck. The engine is still being built and the truck committee will be going up to Pierce again on November 14th for an inspection of the truck.

The new radio system was supposed to go live on November 1st, but it did not and we are still waiting to hear an update.
